



Taxonomic Notes:

Following Arnold *et al.* (2007), *Lacerta laevis* is now named *Phoenicolacerta laevis*. The subspecies *Phoenicolacerta laevis troodica* (Werner, 1936) from Cyprus was elevated to full species status as *Phoenicolacerta troodica* by Arnold *et al.* (2007).

Justification:

Listed as Least Concern in view of its wide distribution, tolerance of a degree of habitat modification, presumed large population, and because it is unlikely to be declining fast enough to qualify for listing in a more threatened category.

Range Description:


This species occurs in southern Turkey (Vilayets Hatay, Adana and İçel), western Syria, throughout Lebanon (where widespread, including on Palm Island), northern Israel and northwestern Jordan. It is found up to 1,800 m asl (in Lebanon).

Population

It is common in suitable habitat.

Current Population Trend: Stable

Habitat and Ecology (see Appendix for additional information)

This reasonably adaptable species is found in rocky forested areas, in meadows, in gardens, on walls of houses and in orchards. It is an egg-laying species.

Systems: Terrestrial

Threats (see Appendix for additional information)

This species is locally threatened by habitat loss in the southern parts of its range.

Conservation Actions (see Appendix for additional information)

It has been recorded in protected areas in Lebanon. It is protected by national legislation in Israel. Further taxonomic studies of this species are needed, and there is a need to conserve areas of suitable habitat in Jordan. It is found in Hatay iskenderun Arsuz wildlife management zone and several other protected areas in Turkey.
